BACKGROUND INFORMATION

The LCA is a 501(c)(3) non-profit corporation formed in 1977 by a group of concerned property owners and local businesses to help in the control of invasive aquatic plant species on Lake Conroe.

Last month, the LCA generously donated \$38,600, to assist in the purchase of 1600 PDU to treat approximately 80-acres of hydrilla on Lake Conroe. The contribution represents approximately one-half of the total cost of the herbicide. LCA has donated funds previously to assist in defraying the cost of hydrilla treatment. SJRA is extremely grateful for their support and partnership in this endeavor.

Staff recommends accepting the donation from the LCA for the purchase of herbicide to treat hydrilla on Lake Conroe.

BACKGROUND INFORMATION

Firm Name: Mbroh Engineering, Inc.

Project: Lake Houston Pump Station Pump and Motor Replacement

Type of Agreement: Professional Services Agreement (Contract No. 23-0054-A WO2)

Project Description/Justification:

The SJRA has identified the need to replace the existing pumps and motors at the Lake Houston Pump Station (LHPS) due to them reaching the end of their expected service life. The LHPS was constructed in 1955 with three pumps and motors that are still in service today. The fourth pump and motor were installed in the 1980s. All four of the existing pumps and motors have been rehabilitated multiple times throughout their service life and the availability of parts and ability to rehabilitate them further is limited. The SJRA also desires to transition the pump station from the existing 2,400-volt (medium voltage) service to a 480-volt (low voltage) service to allow for ease of maintenance on the electrical components of the pump station. The current project consists of the final design and early procurement of four new pumps/motors, associated electrical components, control components, a new overhead crane, new generator, new 480-volt power distribution system, and new HVAC. All new electrical and control equipment associated with the project will be installed in the switchgear room of the Remote Operations Center (ROC) and the existing electrical equipment in the pump station building will be removed/abandoned. The final design includes routing electrical conduits from a new low voltage transformer to the new generator and ultimately the new pumps and motors via the ROC. Early procurement packages will be developed for the pumps/motors, generator, and portions of the electrical equipment as part of this work order to help maintain the project's construction schedule.

Work Order Scope:

Work Order No. 2 includes project management, early procurement package development for long lead time equipment, final design services, procurement assistance, and additional special services. Engineering drawings and specifications will be produced from this work order and used for the project's construction phase.

BACKGROUND INFORMATION

In January 2015, SJRA entered into a raw water supply contract (2015 Contract) with Entergy Texas, Inc. (Entergy). The 2015 Contract provided for the sale of 2.555 billion gallons of water per year (average 7 million gallons per day) from Lake Conroe to Entergy and is set to expire on December 31, 2024. Both parties wish to continue the ongoing contractual relationship, and the proposed contract allows for the provision of raw water through December 31, 2034, with an option for up to an additional ten years beyond the initial term. There is no change in the amount of water to be provided. Entergy is the second largest SJRA raw water customer on Lake Conroe behind the GRP Division. Staff recommends execution of the proposed contract, which will provide continued revenue to the Raw Water Enterprise, helping to maintain stable raw water rates benefitting all of SJRA's raw water customers.

BACKGROUND INFORMATION

In January 2020, SJRA entered into a raw water supply contract (2020 Contract) with Entergy Texas, Inc. (Entergy). The 2020 Contract provides for the reservation of, and sale of up to, 2.555 billion gallons of water per year (average 7 million gallons per day) from Lake Conroe to Entergy. The contract designates the reserved water as coming from the portion of Lake Conroe's yield owned by the City of Houston and reserved by the GRP Division. Based on changes in its operations and water demands, Entergy has requested a reduction in the total amount of water reserved under this contract, from 2.555 billion gallons per year to 1.095 billion gallons per year (average 3 million gallons per day). Staff recommends approval of the proposed amendment, which provides for this reduction in total quantity.

BACKGROUND INFORMATION

In August 2007, SJRA entered into a raw water supply contract (2007 Contract) with Harris County MUD No. 50 (MUD 50). The 2007 Contract provided for the sale of 500,000 gallons per day from the Highlands canal system to MUD 50. The contract was amended in 2015 to update certain terms and conditions related to payment for the contracted water. In order to meet future customer demands and regulatory requirements of the Harris-Galveston Subsidence District, as well as to better align water demands with its development schedule, MUD 50 has requested execution of an amended and restated contract. The proposed contract increases the total contracted quantity of water to 1,500,000 gallons per day, with the entire quantity being reserved until January 1, 2037, at which point 1,000,000 gallons per day will convert to "take or pay." The proposed contract has a term of 30 years, with an option for an additional ten years beyond the initial term. Staff recommends execution of the proposed contract, which will provide increased future revenue to the Raw Water Enterprise, helping to maintain stable raw water rates benefitting all of SJRA's raw water customers.
