## Lake Conroe Park Update



Many of the residents around Lake Conroe are aware of Montgomery County's closure of Lake Conroe Park in early 2024. In July, Montgomery County Commissioner's court voted to terminate agreements with SJRA that includes the operation of the Lake Conroe Park. In that same month, the SJRA Board agreed to terminate the agreements, and SJRA Staff did extensive research and put together various options to continue operating the Park. As a result of financial, legal, regulatory, and operational issues the Authority has decided to move forward with a solicitation for Request for Information (RFI) for a Concessionaire to run Lake Conroe Park.
